

## **RESIDENTS REJECT PLAN** FOR NEW SUBDIVISION

## MANY FEEL IT'S TOO MUCH FOR EXISTING **NEIGHBOURHOOD**

Area residents are demanding council put a stop to a proposed subdivision a developer is hoping to build in the middle of an existing Oakville neighbourhood.

During the Tuesday, Sept. 8 meeting of the Planning and Development Council, Branthaven West Oak Inc. called for zoning changes that will permit it to construct 59 townhouses on a 1.17hectare property located at the northwest corner of West Oak Trails Boulevard and Postmaster Drive.

proposed subdivision The would consist of 26 two-storev townhouses, 14 three-storey backto-back townhouses, and 19 threestorey rear lane townhouses.

The property would feature a condominium road.

The developer also wants to change the maximum building height from 12 metres to 13.5 metres

The land is surrounded on all sides by existing semi- and singledetached dwellings with some

townhouses to the east.

The proposal to build so many new townhouses within an existing community has many there concerned.

Some said they are worried about the increased traffic congestion and traffic safety issues they fear this development will bring.

"As a resident with over 10 vears in this neighbourhood. I have personally seen the gradual increase in the number of vehicles passing through the intersection of Postmaster and West Oak Trails," said Piyush Aghi.

"You have 59 townhouses proposed and with an average of two cars per household, that is more than 100 cars added to our neighbourhood."
